We are submitting this further submission to oppose specific points in the original submissions that support the current boundaries of the proposed Te Rapa North Industrial Zone, as our properties have been excluded from this rezoning despite their proximity and suitability for inclusion.</p> <p>We oppose submission point 1.3 from Submitter 1, which supports the current extent of the proposed Te Rapa North Industrial Zone without including our properties at 11 and 37 Meadow View Lane.</p> <p>Reasons for Opposition</p> <p>a. Inconsistent Land Use Planning</p> <p>Excluding our properties from the industrial zoning creates an inconsistent land use pattern. Our properties are</p>

adjacent to those proposed for industrial development and share similar characteristics, making them suitable for inclusion. This exclusion undermines coherent urban planning and may lead to fragmented development.

b. Economic Disadvantage

By not including our properties in the industrial zone, we are deprived of potential economic opportunities that neighboring landowners will benefit from. This exclusion could negatively impact the value and utility of our land, placing us at a competitive disadvantage.

c. Missed Opportunity for Integrated Development

Incorporating our properties into the industrial zone would allow for a more comprehensive and integrated development of the area. It would facilitate better infrastructure planning, traffic management, and service provision, benefiting the broader community.
