We are writing to make a submission in conditional opposition to Plan Change 17. We are the landowners at 11 and 37 Meadowview Lane, which lies within the deferred Industrial Zone neighbouring the area subject to this proposed plan change. I oppose the rezoning of the Fonterra site from deferred Industrial to the Rapa North Industrial unless surrounding properties - including ours - are also included in the proposed rezoning.
