<p>Q14</p> <p>Long Text</p>	<p>My submission is that</p> <p>We are the property owners of 11 and 37 Meadow View Lane, which lies within the Deferred Industrial Zone neighbouring the area subject to this proposed plan change.</p> <p>We oppose the rezoning of the Fonterra site from Deferred Industrial to Te Rapa North Industrial unless surrounding properties – including ours – are also included in the proposed rezoning.</p> <p>The proposed rezoning unfairly benefits one landowner (Fonterra) while leaving adjacent landowners in planning limbo. Our land is similarly zoned (Deferred Industrial), and we face the risk of being excluded from future infrastructure planning, investment, and development pathways if not included now.</p> <p>We are concerned that, by not being included in this rezoning, our properties and the wider Meadow View Lane community will be overlooked or delayed indefinitely in future zoning reviews.</p> <p>There is strong local concern: most, if not all landowners on Meadow View Lane have submitted in opposition unless inclusion is extended to all deferred zone properties.</p>
