Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

Your request:

I'm interested in what options/innovations HCC has evaluated re water services alongside the proposed management reforms & current mega plans for additional reservoirs plus the new Waikato treatment plant. I'm aware that Hamilton's water treatment plant has capacity to treat up to 106 million litres/day, and that people require on average c5litres/day for drinking & cooking (& teeth cleaning!) which equates to less than 10% of the total treated water provided. Please provide information on supply innovations and/or incentives relating to residential potable/drinking water services including rainwater & grey water storage options for gardening and other appropriate usages, and how this fits with water metres.

Our response:

Your request was quite broad we have been able to provide the below. If there is something specific that you would like further details on please let us know.

District Plan Changes – PC12

Council proposed a rule with mandatory requirements for re-use tanks within residential zones as part of notification of Plan Change 12 as part of a suite of [green policies](#). As part of the Plan Change process under the RMA this rule did not survive in its original form. Rule 25.13.4.2a resulting from the decisions on PC 12, now has a performance standard for retention of stormwater onsite, the solution for which (depending on the development and ground conditions) may include the installation of reuse tanks for grey water purposes. Council is currently reviewing it's [practice notes](#) as part of PC12 , however current guidance can be found [here](#).

Smart water

CoLab (a joint Council CCO) provides Trade Waste, Sampling and Analysis and Smart Water services to a number of Waikato Councils including Hamilton City Council, part of this initiative includes education on water use, more information on this can be found [here](#).
