We are just wanting to add some additional explanation to the FTE staff numbers. Please see below.

Full time equivalent staff numbers - as of Feb 25 - 1,283 FTE - (Noting vacancies against approved establishment of 1,452 as at February 2025, down from the prior establishment of 1,560, reflecting a reduction of 108 following Councils resolution on its "Future Fit" programme reflected in long term Plan 2024-34).

### **Information requested for 2025**

The comparative information on 30 June 2025 will be available within the 2024-25 annual report, which is due to be adopted following external audit by Audit New Zealand in October 2025.

We have provided the equivalent interim information as of February 2025, however it is important to note this information, though prepared consistently with our annual report processes, is not audited.

1. Annual Staff Wages and benefits cost - 8 months YTD Feb.25 (\$,000) - \$82,890
2. Annual consultants/advisor cost - 8 months YTD Feb.25 (\$,000) - \$4,692
3. Full time equivalent staff numbers - as of Feb 25 - 1,283 FTE
4. Actual staff numbers - 1,392 total employees

We have supplied the information from February as providing this information any further would be substantial collusion, we have looked at charging but doing this work would still impact the daily duties of staff so this is refused in part under s17(f) of LGOIMA.
